

# INTRODUCTION

We are pleased to confirm that, after consultation with scorers across the game, we are launching a new education and development pathway.

This pathway is designed to provide clarity as to what is expected of scorers at all levels of the game, with structured learning opportunities being provided to support scorers' development.

The diagram below shows the different levels of the ECB Scoring Pathway:



# TRANSITION FROM EXISTING PATHWAY

ECB ACO members eligible to transition to the new pathway will be informed of their new grade/level, separately.

The table below shows the criteria considered when allocating scorers to their new grade/level.

| New Level in Pathway                         | Requirements   |
|--|--|
| <b>S1</b> Professional Game                  | Previously accredited at Level 3 with ECB Scoring Authorisation  |
| <b>S2</b> Representative Game – Professional | Previously accredited at Level 2 with ECB Scoring Authorisation  |
| <b>S3</b> Representative Game – Recreational | Previously accredited at Level 3 without ECB Scoring Authorisation<br>OR<br>Previously accredited at Level 2 without ECB Scoring Authorisation |
| <b>S4</b> Recreational Game                  | Previously accredited at Level 1, regardless of ECB Scoring Authorisation  |
| <b>S5</b> Team Scorer                        | No previous accreditation  |

# ELIGIBILITY FOR PATHWAY

The ECB Scoring Pathway is open to all scorers.

To obtain the level of Team Scorer (S5), scorers must have completed the ECB Scoring Course and be a Full member of the ECB ACO.

To progress beyond S5, scorers must be full members of the ECB ACO.

# COMPETENCE FRAMEWORK

---

A full Competence Framework supports the Scoring Pathway, defining the knowledge, skills and behaviours needed at each level. It serves to guide a scorer's personal development, as well as ensuring a transparent and consistent approach to grading and promotion.

The Competence Framework can be found as **APPENDIX A**.

Scorers are encouraged to use the framework as a reference point for their own self-reflections and County ACO Lead Scorers - Development should refer to it when completing any mentoring or providing support for their scorers.

County ACO Lead Scorers - Development are asked to use the Progression Discussion Report as the basis for all progression discussions with scorers, and to help shape the on-going support and mentoring for scorers seeking promotion on the ECB Scoring Pathway. The report ensures a standardised approach to Progression Discussions and allows for written feedback to be provided, with a structured next steps section to help with ongoing support. The Progression Discussion Report form template can be found as **APPENDIX B**.

County ACOs, league panels and other appointing bodies are encouraged to provide educational sessions that align to the Competence Framework.



# WHAT DO THE LEVELS MEAN?

Different types of cricket are associated with each level. If, for example, you are an 'S3 – Representative Game Scorer – Recreational', then the types of cricket you would normally be expected to score would include National Counties, ECB County Age-Group competitions and Women's Tier 3 cricket.

The table below shows the types of cricket typically associated with each level of the pathway.

| Level   | Types of Cricket  |

| <b>S5</b> Team Scorer                               | Adult Club Friendlies and Low-level league fixtures, Junior Club Cricket, Last Man Stand cricket, Indoor cricket.   |
| <b>S4</b> Recreational Game Scorer                  | All other Adult League cricket, ECB County Age Group Friendlies, BUCS Cricket, Non-ECB Adult Cup competitions (e.g. Cricketer Cup), Schools Cricket Disability Cricket, County Masters Cricket (e.g. 50+).                                |
| <b>S3</b> Representative Game Scorer – Recreational | National Counties Cricket, National Disability Cricket Competitions (e.g. Disability Premier League), ECB County Age Group Competitions, MCC Matches, Women's Development and 2nd XI Cricket, Women's Tier 3 County Cricket Competitions. |
| <b>S2</b> Representative Game Scorer – Professional | ECB Festivals (Bunbury, Super 4's Men and Women), ECB County U18 & U16 Boys cricket, Men's Professional 2nd XI Cricket, Women's Tier 1 Academy and Tier 2 Cricket.  |
| <b>S1</b> Professional Game Scorer                  | Men's Professional 1st XI Cricket, Senior England Women's Competitions and Matches, Women's Professional Cricket, England Lions & U19 (both genders), The Hundred.  |

# PROGRESSION ARRANGEMENTS AND PROCESS

---

Outlined below are the requirements for scorers to achieve promotion on the ECB Scoring Pathway.

Any scorer who is interested in applying for promotion during the 2026 season must submit an “Expression of Interest” form\* to their County ACO Lead Scorer - Development, no later than 30th April 2026. A copy of this form is available as **APPENDIX C** or can be obtained via the County ACO Lead Scorer - Development. Any scorer who is not aware of their local County ACO contact should e-mail [ecb.aco@ecb.co.uk](mailto:ecb.aco@ecb.co.uk).

Please note, the achievement of a level within the ECB Scoring Pathway does not guarantee a scorer receiving scoring opportunities within certain types of cricket. This is due to the high number of eligible scorers that may exist in an area for those opportunities. Your County ACO Scoring Lead - Appointments will advise you on local opportunities that are available.

\*A scorer seeking the entry point of Team Scorer (S5) does not need to submit the “Expression of Interest form” as this grade can be achieved at any time during the season by completing the ECB Scoring Course and joining the ACO.

### **Team Scorer (S5)**

In order to obtain the level of Team Scorer (S5), the scorer must evidence the following:

- Completion of the ECB Scoring Course
- Be a Full member of the ECB ACO

Achievement of the S5 grade is available at any time and will be managed by the ECB Officiating Department.



### **Team Scorer (S5) to Recreational Scorer (S4)**

In order to obtain the level of Recreational Scorer (S4), the scorer must evidence the following:

- Having scored a minimum of 7 (seven) games in the current season
- Completion of the Scoring Techniques Educational Session\*
- Completion of the Duckworth Lewis-Stern (DLS) Educational Session

The completion of these educational sessions must be within 3 years of application for promotion. This will be managed by the County ACO Scoring Lead - Education, using attendance information from the ECB central bookings system.

The scorer applying for promotion is responsible for ensuring that evidence of meeting the above criteria is sent to the County ACO Lead Scorer - Development by no later than 30th September 2026. The County ACO for which the Scorer is a registered member will notify the outcome to the Scorer by the end of November 2026.

### **Recreational Scorer (S4) to Representative Game Scorer - Recreational (S3)**

In order to obtain the level of Representative Game Scorer - Recreational (S3), the scorer must evidence the following:

- Having scored a minimum of 10 matches across 2 consecutive seasons
  - A minimum of 5 of these matches must have been scored on Play-Cricket (PCS Pro).
- Completion of the MCC Basic Laws test, achieving a mark of 75% or higher during the season of application.
- Completion of the Linear Scoring Educational Session.
- Completion of the PCS Pro Educational Session.
- Completion of the Statistics Educational Session.
- Completion of a Progression Discussion with a Scorer Developer.

The scorer applying for promotion is responsible for ensuring that evidence of meeting the above criteria is sent to the County ACO Lead Scorer - Development by no later than 30th September 2026. The County ACO for which the scorer is a registered member will notify the outcome to the scorer by the end of November 2026.



### **Representative Game Scorer – Recreational (S3) to Representative Game Scorer – Professional (S2)**

In order to obtain the level of Representative Game Scorer – Professional (S2), the scorer must evidence the following:

- Having scored a minimum of 10 games across 2 consecutive seasons at the S2 Level
  - All matches scored to be on Professional Database.
- Completion of the MCC Basic Laws test, achieving a mark of 75% or higher during the season of application.
- Completion of the ECB Scoring Authorisation.
- Completion of a Progression Discussion with a Scorer Developer.

The scorer applying for promotion is responsible for ensuring that evidence of meeting the above criteria is sent to the County ACO Lead Scorer - Development by no later than 30th September 2026. The County ACO for which the scorer is a registered member will notify the outcome to the scorer by the end of November 2026.



## **Representative Game Scorer (S2) to Professional Game Scorer (S1)**

In order to obtain the level of Professional Game Scorer (S1), the scorer must evidence the following:

- Having scored a minimum of 15 games across 2 consecutive seasons at the S2 Level
  - All matches scored to be on Professional Database.
- Completion of MCC Basic Laws test, achieving a mark of 75% or higher during the season of application.
- Completion of the ECB Scoring Development Programme\*.
- Completion of a Progression Discussion with a Scorer Developer.

The scorer applying for promotion is responsible for ensuring that evidence of meeting the above criteria is sent to the National ACO Lead Scorer - Development by no later than 30th September 2026, to [officiating@ecb.co.uk](mailto:officiating@ecb.co.uk). The National ACO will notify the outcome to the scorer by the end of November 2026.

Please note that achievement of Professional Game Scorer (S1) grade does not guarantee opportunities to score in professional cricket due to the volume of eligible scorers, with limited professional scoring opportunities available.

\*The ECB Scoring Development Programme will be available ahead of the 2027 season. In the interim, those eligible candidates will be offered an equivalent learning experience to prepare them for potential promotion.

# SUPPORTING EDUCATIONAL OFFER

---

As outlined above, the County ACO network is on hand to offer the following educational sessions to their members:

## **Scoring Techniques**

This session introduces scorers to regular, repeatable scoring routines to ensure accuracy when scoring, how the umpiring and scoring teams work together for the smooth running of the game, key Laws of Cricket and how to accurately record penalty runs.

## **Linear Scoring**

This session introduces scorers to Linear Scoring, explains the theory behind it, why a scorer might choose to use Linear Scoring and teaches the method by putting the skills into practise to improve the scorer's competence and confidence.

## **Duckworth-Lewis Stern (DLS)**

This session introduces scorers to the theory behind DLS, the theory to manually calculate DLS target scores, the terminology involved and how to use the DLS calculators within PCS Pro and the Play-Cricket Scoring App.

## **Statistics**

This session introduces scorers to the theory and relevance of certain statistics that are required of a scorer to perform during a game, understanding how to record and report on relevant interruptions both when scoring manually and electronically.

## **PCS Pro Scoring**

This session introduces scorers to scoring cricket matches via the Play-Cricket Scorer Professional (PCS-Pro) software and database, covering all key aspects from fixture creation and team selection to methodology on how to score a match and finalise the result accurately.

These educational sessions will be delivered in County, by County ACO Scoring Tutors and advertised to members via local newsletters or other communications. These will also be made available via the ECB Website. Click [\*\*here\*\*](#) to access.

## **ECB Scoring Development Programme**

Launching in 2027, the ECB Scoring Development Programme will support the additional learning of scorers who are looking for progression from the Representative Game Scorer – Professional (S2) to the Professional Game Scorer (S1) levels. This programme will cover the key differences from operating in 2nd XI professional men's cricket through to the full professional game, including the key regulations around anti-corruption, working practices in the professional game and working with key stakeholders (for example broadcast colleagues, match managers, etc).



# **MCC LAWS OF THE GAME TEST**

---

# SCORING PATHWAY COMPETENCE FRAMEWORK

## Preparation



### **Representative Scorer - Recreational**

- Has an established routine to plan and prepare for a forthcoming match
- Talks to appropriate match and ground officials as part of their pre-match routine
- Identifies and pursues learning and development opportunities
- Accepts appointments in a timely and professional manner
- Have identified the appropriate scoring method for the match and can adapt accordingly



### **Representative Scorer - Professional**

- Has obtained ECB Scoring Authorisation prior to match day
- Knows the difference between electronic scoring systems



### **Representative Scorer - Professional**

- Understands need for competition accreditation and has in-depth knowledge of correct usage
- Arrives 2 hours before the start of match to address any issues
- Professionally dressed, appropriate to match and setting
- Ground specific knowledge (e.g. scorebox location, scoreboard requirements, etc.) sourced prior to arrival
- Thorough research of teams conducted prior to arrival, to support on day scoring performance

## Scorebox Technique & Scorebox Etiquette



**Team  
Scorer**

- Ensures required information is provided from key stakeholders, e.g. named players, who won the toss, etc.
- Understands the need for scoring routines (scoring sequence, how to watch the match)
- Records events on the field of play factually, e.g. short & long overs
- Can use electronic scoring as relevant to the game
- Can complete a standard paper scoring record accurately
- Knows the regulations for a batter retiring and how to record
- Can identify and record the score as per Law 3 of MCC Laws of cricket and differences between symbols used in paper and electronic scoring
- Can identify and record Maidens and Wicket Maidens factually
- Can understand the different types of extras and can record consistently
- Can identify the different dismissals and record how out appropriately (scoresheet entries include fall of wicket and fielders' names)
- Can recognise basic umpire signals
- Can identify when runs are scored
- Has an awareness of the impact of short runs and overthrows

## Scorebox Technique & Scorebox Etiquette



### Recreational Scorer

- Can identify own team members and recognise differences between players
- Has clear, established scoring routine including regularly checking own recordings
- Is aware of distractions but remains focussed on the match
- Records all interruptions in play accurately
- Awareness of scoring process for disallowed leg byes
- Records correct names of batters, regardless of whether they bat or not
- Knows when the winning run is scored
- Understands, and can record accurately, the difference between Not Out/Did Not Bat/ Absent
- Can identify and qualify the result
- Can finish off the game correctly, including the completion of any missing data
- Can use Duckworth Lewis-Stern as required for your match
- Understands how to record penalty runs
- Understands the impact of player suspension and how to record accurately
- Can score matches using Play-Cricket Scorer Pro basic package and Play-Cricket Scorer App advanced levels.

## Scorebox Technique & Scorebox Etiquette



### Representative Scorer - Recreational

- Clear, consistent, accurate, legible and timely recording of events using appropriate/ required scoring method (book and/or electronically)
- Fully aware of scoring position and gives consideration to their colleague
- Confident, remains calm in their recording of game events
- Demonstrates thorough knowledge of MCC Laws of Cricket plus competition rules and regulations applicable to scorers
- Understand the impact of the following scenarios and recording appropriate:
  - Run out of non-striker without delivering the ball
  - Substitutes (including concussion substitutes as per competition regulations)
  - Dead Ball (how to record, does it count as delivery in over)
  - Can record basic stats including strike rates, economy rates, averages and partnerships
  - Can accurately manage the following scenarios in the following contexts:  
Match points, Interruption timings / state of play, Last hour of play, Intervals that affect timings, Multi-day over rates, Follow on, New ball taken, End of day in Play-Cricket Scorer

# FREQUENTLY ASKED QUESTIONS

## **How do I get on the Pathway?**

To be on the scoring pathway, scorers are required to join the ECB ACO and, as a minimum, complete the ECB Scoring Course (Free to access).

For those who are “rejoining” the ECB ACO, arrangements have been made within the pathway to account for previous or assumed levels of knowledge and these will be managed via County ACO Scoring Leads - Development.

## **I don't agree with my level on the new Pathway. What should I do?**

Please speak to your County ACO Scoring Lead - Development who can investigate and correct, in conjunction with the ECB Officiating Department.

## **I've been a scorer for years. Do I have to start at the beginning again?**

There are transitional arrangements for those with previous experience to be measured against the Competence Framework and please speak to your County ACO Scoring Lead - Development for details.

## **Do I have to join the ECB ACO?**

If you wish to progress on the ECB Scoring Pathway, then individuals are required to be full members of the ECB ACO.

## **How do I get a Progression Discussion?**

## **Who decided what level I am on the new Pathway?**

The transition arrangements have been outlined in previous correspondence with current ECB ACO members. If you are unsure that you are on the appropriate grade, please speak to your County ACO Scoring Lead - Development.

## **Who worked out the competencies for each level?**

Work was undertaken across the 2024 and 2025 season, collaborating between existing scorers and the Scoring Sub-Committee of the ECB ACO to build a competence and educational framework to support scorers at every level of the game.

## **What is the ECB Scoring Authorisation?**

The ECB Scoring Authorisation is an additional piece of education which enables scorers access to scoring on the Professional Database. Examples of matches on this database can be Women's Tier 2 competitions, Men's Under 18 County matches. Counties use the Professional Database.

Whilst scorers may have completed the ECB Scoring Authorisation, this does not guarantee scoring opportunities at that level.

## **I only want to score for my club. Does that mean I can't do the CPD Modules or become a Professional Scorer (S1)?**

The pathway is designed to support the development of scorers to enable their progression from club-based scoring to higher levels of the recreational game and potentially into the professional game.

There is no requirement for scorers to progress up the pathway, however the ECB Scoring Pathway has been designed to support scorers in the various levels and types of game where they may operate and support the growth of scoring across the game.

## **I took a break from scoring but want to come back. What do I need to do?**

Firstly, if you wish to be on the ECB Scoring Pathway, then registering with the ECB ACO is the first step. Secondly, the ECB Scoring Course is available to anyone, at any time, to review their scoring techniques and to refresh their skills when scoring on Play-Cricket.

Then, speak to your County ACO Scoring Lead - Development about further progression opportunities.

## **Can I progress more than one level on the Pathway in a season?**

Initially, it is only possible for a scorer to receive promotion of one level in a season.

## **What if I don't agree with the outcome of my PD?**

Appeals can be made to the National Scorer Officer - Development or to [officiating@ecb.co.uk](mailto:officiating@ecb.co.uk) for review.

## **How do I get higher-level matches?**

Speak to your County ACO Lead Scorer - Appointments, who can support you on a local basis.

## **I did some training years ago. Does that still count?**

Transition arrangements have been made for those who completed ACO scoring training since 2021.

We believe that scorers should access developmental or educational offers provided by the ECB and County ACO network as they see fit, based on their current skills in line with the Scoring Competence Framework.

## **Can I be on the Umpires Pathway and on the Scorers Pathway?**

Yes.

## **I live in a small county with an NCCA club. Can I still get to the Professional levels?**

There is no reason why you can't achieve this, however the appointment of scorers within the professional levels of the game is the responsibility of the First-Class County Clubs.

## **How much do the courses and modules cost? What if I can't afford that?**

Educational courses, as part of the ECB Scoring Pathway are included within the full ECB ACO Membership, so they are available for most individuals. If you have financial concerns preventing your attendance, please speak to your County ACO for support.

## **Does where I live affect the matches I can be appointed to?**

The appointment of scorers is the responsibility of the host club. As such, we cannot comment on this.

## **Can I apply to be a Professional Scorer (S1), or do I have to be nominated by someone? If so, who?**

Applications to achieve the Professional Scorer (S1) grade are welcome from anyone who is a Representative Game Scorer - Professional (S2). Please see the required criteria for those applicants to be successful.
